


2. State Of Company's Affairs

Jungwa Foundation (hereinafter referred to as Foundation) was incorporated on 27th February, 2018 as a private limited company under Section 8 of the Companies Act, 2013. The Foundation works for the interconnectedness and interdependence of Nature and Culture through a common framework that support conservation, long-term sustainability and integrity of the web of life on Earth. The wisdom of local communities that has transpired over centuries of interactions with nature is indispensable to tackle socio-ecological change. Thus, by combining traditional knowledge practices, worldly wisdom with modern science – the Foundation aims to foster resilient ecosystems, biodiversity, and communities including their livelihoods, health, sanitation and cultural well-being.

3. Activities carried by the Foundation during the year under review

The year saw a continuing focus on our flagship project of creating sustainable rural livelihoods in Changthang and documenting and disseminating traditional knowledge on the nomadic pastoral culture of the Changpas of Korzok. Workshops with school children were expanded with the organization of a month-long theatre workshop based on a Changpa legend of the creation of the lakes of Changthang. An exciting new project commenced this year - documentary film that explores climate change through the lens of traditional culture of the Changpas of Korzok Tegazung which is being produced in collaboration with Korzok monastery and with the kind permission of the Office of the Chief Wildlife Warden, Leh, UT Administration. The research on the precinct of Leh Palace and Namgyal Tsemo was expanded this year to cover the urban evolution of historic Leh city.


LIVELIHOODS PROGRAMME - WEAVING






The focus for this year's program was an extension of the livelihoods weaving program weaving to reach an expanded network of nomadic families in Korzok tegazung. The program continued with its efforts to promote the skills of back strap loom weaving using locally sourced sheepwool.

A field workshop was held in Korzok during the summer months when the Changpa are camped at the *phu*. The workshop led by Jungwa Foundation's team, imparted training on back strap loom weaving for a range of products developed by the team. Interactions with workshop participants also shed light on a range of traditional motifs and textiles woven by them. Simultaneously, a shorter session on hand spinning was conducted. Following the training, the network of households reached through the program has expanded to 35.





Jungwa Foundation participated in several exhitions organised by the Department of Handicrafts and Handlooms, Leh. This included the Enchanting Ladakh event held at Dilli Haat, in January

CHANGPA MIGRATION DOCUMENTATION






In

our continuing efforts to better understand the unique nature-culture linkages of the Changpa community of Changthang, a mapping of migration routes was undertaken in the two bocks of Nyoma and Durbuk. In Durbuk, the nomadic way of life is on the decline and knowledge on migration routes is held by a few elders from the community. Through a series of personal interviews and transect walks, migration routes were mapped with a special emphasis on Changpa place names. This is an ongoing project.

The nature and culture in education was continued in summer this year. The walks are led by the team from Young Naturalists of Ladakh (YNL) a group of young Ladakhis trained by us in 2021. Butterfly and bird watching walks were held with school students in summer. Government Middle School, Tashi Gyatsal and Ladakh Rigjung Public School.



World Environment Day was celebrated in June, with a theatre performance by students from Government High School, Kharnakling based on a story of Yultsa Gatpo and the Lakes from our book "Tales from the Rebo". A month long theatre workshop was organised with the students prior to this which was led by noted theatre artist, Tsering Yangchen. Through the workshop, children were guided on public speaking, team building and other life skills as they developed the script for the play. The importance of theatre in education is recognised by Jungwa Foundation and it is proposed to conduct similar workshops in Changthang in the future. The final performance, held on World Environment Day at the school was a huge success with the parents, students and staff. Chief Guest Sh. Tundup Nurbu, Councillor LAHDC and Guest of Honour, Smt. Rigzen Angmo, Zonal Education Officer lauded the efforts made by the students and congratulated Jungwa Foundation on conducting a successful workshop.








DOCUMENTARY FILM ON CLIMATE CHANGE THROUGH THE LENS OF CULTURE

Jungwa Foundation has been partnering with Korzok Monastery over the past several years to impart training on monastic ritual arts, an invaluable part of Korzok's Intangible Cultural Heritage. Monastic Ritual arts have profound meaning deeply embedded in the Buddhist worldview which underlines the close links between nature and culture. A documentary film is now being produced as a collaboration between Korzok Monastery and Jungwa Foundation, with the kind permission of the Office of the Chief Wildlife Warden, UT Administration Ladakh, that situates the ICH training in the larger framework of pastoral nomadic life of the Changpas of

Changthang, exploring climate change through the lens of culture. The documentary film provides a rare opportunity to document the rapidly changing life of the Changpas, their close links with the landscape and their culture through interviews with monks, elders and young herders, from Korzok. The film is being written and directed by noted Ladakhi film maker, Stanzin Dorjai Gya. This is an onoing project.

RESEARCH ON HISTORIC CITY OF LEH

Following the submission of a report on the architectural documentation of the Leh Palace and Leh Namgyal Tsemo to the Archaeological Survey of India, research on the larger historical context of the precinct was initiated. The research project aims at tracing the urban evolution of the historic city of Leh, one of the last surviving trans Himalayan earthen settlements. This is an ongoing project.
